THE ALCALDE DOES NOT WORK FOR THE EL PASO COUNTY WATER IMPROVEMENT DISTRICT NO. 1

EL "ALCALDE" NO TRABAJA PARA EL PASO COUNTY WATER IMPROVEMENT DISTRICT NO. 1

The scheduled days shown for your Group does not mean you can irrigate on all of the days shown. Community Ditches are scheduled to irrigate on a certain day at a certain time. The Alcalde must pickup the irrigation water within one (1) hour of the scheduled time or the turnout will be locked. If you miss your scheduled date and time, you can not irrigate until the next scheduled date and time. **If the Alcalde has property on the community ditch, their account must be paid before the irrigation season starts or the entire community ditch will not receive the irrigation water.** Your community ditch and the banks must be kept clean at all times. **DO NOT EXPECT US TO TELL YOU WHEN YOUR DITCH AND/OR BANKS ARE DIRTY. DO NOT EXPECT TO GET IRRIGATION WATER IF YOU WAIT UNTILL THE LAST MINUTE TO CLEAN THE DITCH AND/OR BANKS. IF A COMMUNITY DITCH AND/OR BANKS ARE DIRTY, NO WATER WILL BE ALLOWED TO BE RELEASED FROM OUR TURNOUT.** The Alcalde or their designated assistant needs to notify the ditchrider and the dispatcher (915-872-4029) when they are finished irrigating. The Alcalde or their designated assistant **CANNOT** close their turnout (unless they are done watering) or reduce the flow of the water or the District will close the turnout and lock it until the next scheduled irrigation. If a flooding occurs on a community ditch, the turnout will be shut down and locked. If flooding's continue, the turnout will be closed until the problem is corrected. Small Tracts are charged whether they use 1 irrigation or all scheduled irrigations. The reasoning behind this is that the Irrigation District provides surface irrigation water to every water user when scheduled. Whether or not a water right landowner utilizes the scheduled irrigation(s) is their choice. The Alcalde needs to notify the dispatcher (915-872-4029) if the community ditch will NOT pickup the irrigation water. *Los días asignados para su Grupo no significa que pueden regar todo los días. Las Acequias de Comunidad tienen un cierto día y una cierta hora para empezar a regar. Si no riega en la fecha y hora asignada para su Acequia de Comunidad, no podra regar hasta el proximo riego asignado. Si tienen cualquier pregunta, favor de llamar al Coordinador al 915-872-4000. Se prohíbe el uso de manjeras de cualquier tipo para recuperar la agua de irrigacion de nuestro canal. Si usted es el "Alcalde" y tiene una propiedad en la Acequia de Comunidad, debe pagar su cuenta antes del comienzo de la temporada de riego, o la acequia de comunidad entera no recibira el agua. El "Alcalde" no puedo cerrar la compuerta (a menos que haya terminado) o reducir el flujo de agua de la acequia de lo contrario el distrito cerrara la compuerta. Las parcelas pequeñas seran cobradas si usan una o todas las irrigaciones asignadas. La razón, es que el distrito de irrigación provee de agua de irrigación superficial a todo usuario que este bajo la agenda. Si el usuario decide o no hacer uso de su derecho a riego es su decisión. **SI EL CANAL DE LA COMUNIDAD ESTA SUCIO, EL AGUA DE NUESTRA COMPUERTA NO VA SER LIBERADA. NO ESPEREN UN AVISO CUANDO SU CANAL NECESITE SER LIMPIADO. Y NO ESPEREN AGUA SI LIMPIAN EL CANAL HASTA EL ULTIMO MOMENTO.***
